c) Barcelona abstract: Alice is proud to announce that the submitted paper entitled: Development of a National HIV/AIDS Pharmacists Network in Canada has been accepted at the International AIDS conference held in Barcelona this July. However, due to space constraints, it will not be posted in place but only included in the abstract book and CD-Rom.

2. New Projects

A) Position paper on TDM :

Rolf elaborated on TDM and its potential role in the treatment of HIV. Rolf indicated that TDM is still at a research stage and is not yet considered standard practice. It was proposed that CHAP network express his opinion and write a position paper on TDM and HIV treatment. Rolf is going to be the leader in this project.

B) ddI EC project

Pierre is interested to design a study to look after the safety and the efficacy of switching regular ddI to its enteric formulation. After a quick roundtable, it was noted that only BC and Edmonton has a program in place to cover the EC formulation. Pierre asked all members interested to participate in a future multicenter study to keep a record of the patients switched to EC. He will contact the members once a draft of the study design will be in place.
