Provided overview of CHAP budget and accounts

- Two CHAP accounts one for AGM and other for managing projects/research
- Meeting Expense AGM 2014 22 attendees, \$22,500 for 15 travel grants (13 working group members, 2 non-working group), AGM 2013 total meeting expenses = \$35,897.93 with \$50, 880.23 carried forward (reserve). Review historical AGM travel grants past 10 years: range 10-19 travel grants/ year with total travel grant costs/year range \$13,000-28,000.

  - Role in HCV (including monoinfection) round table discussion about some HIV pharmacists now also providing clinical care for HIV/HCV-coinfected patients and some for HCV monoinfected patients. No increased funding for additional workload/incorporated into role. Discussed the need to acknowledge the growing role of HIV Pharmacists involvement as it pertains to CHAP and discussion about including in CHAP mission statement: to include "viral hepatitis"
- CHAP accounts and handling project/research funds Alice reviewed logistics of having two separate
  accounts one for general and other for project/research. Piloting of two accounts with Screening
  Tool project working well
- New projects:
  - HIV testing in community pharmacies (Debbie Kelly) discussion about new project in development regarding Point of Care Testing (POCT) by pharmacists in community

Meeting with CATIE - Collaboration on HCV initiatives

Laurie Edmiston (CATIE Executive Director) – evolution of CATIE to including HCV monoinfection and HIV/HCV coinfection reflected in change to CATIE's mandate. Continue to use same name CATIE but acronym no longer applys. Discussion about the change in funding towards HCV and the growing need for HCV information – both mono and coinfected. CHAP and CATIE have previously collaborated on other projects related to HIV and discussion about how can potentially collaborate with HCV information – development of drug information for CATIE website, CHAP members act as reviewers needed for drug information developed by CATIE. Suggested that anyone/volunteers with interest to contact CATIE directly. Request that CATIE link be added to CHAP website.

## Research

Pierre – presented 2 studies. The results of a study on DRVr-TVD in PEP to be presented at CAHR 2014. They measured prospectively side effects, QoL and adherence during the first and last week of treatment. Summary - adherence was very good (>90%) and the side effect profile was favorable. Tolerance greatly improved over time. Other study was an update on their microboosting study. This study evaluating RTV 50mg vs 100mg with ATV300mg and nukes. He provided the rationale of the study, and an update on the accrual.

 CANDY Study – Alison for Nancy. PK study of ARVs in diabetics, needing to enrol diabetics and looking to potentially expand to other sites for enrolment. If interested to contact Nancy.
