We are having a very nice fall season so far here in Montreal. Nice weather, very little rain and we are slowly preparing for our next big step,

moving in the « nouveau CHUM » (probably next fall). We have finalized our model for providing HIV pharmaceutical care for outpatients and inpatients in the new Our model of practice will superhospital. consist of 2 full time HIV-specialized pharmacist positions, present from Monday to Friday in the « Nouveau CHUM ». One will be responsible for HIV outpatients at the clinic and another pharmacist will cover inpatients. It will be great to finally all work together in one site and thus no moving between different hospitals and from the hospital wards to the outpatient clinic many times per day! We are expecting a busier clinic than ever with the merger of patients from UHRESS Hôtel-Dieu and from UHRESS Notre-Dame in the same clinic.

Rachel is still busy with her drug-drug interaction website and leaflets on new hepatitis C direct-acting antivirals (DAAa) should be ready soon. Suzanne and Rachel are preparing for our annual HIV symposium at the end of November where they will present clinical cases on drug-drug interactions with DAAs, antiplatelets/ anticoagulants and antiretrovirals.

On my side, we have developed a tool, along with a pharmacist in oncology and with hepatologists, on the management of HBV prophylaxis when initiating chemotherapy. Our goal is to implement our protocol as soon as possible and we will giving presentations to oncology be colleagues soon. I also have to work on the CHAP HCV drug coverage tool. Unfortunately, I am behind schedule as I was waiting for HCV drug coverage decision in the province of Quebec which we now have. Therefore, there should be more to come about this tool later on this year!

We have finally made the big move to our dazzling new hospital (...dazzling on the inside)! The move itself went great, very efficient, very controlled etc. I hope not too much of the bad press made it to each of your provinces but there are some small issues with drainage, the computer systems crashing and some other inconveniences.

Apart from that, our patients have followed us to the new Chronic Viral Illness Service clinic and, since our office is now directly opposite of the physicians, we have been significantly busier than before with consultations!

Since our move to the mega hospital, we have also taken the initiative to cover hospitalized patients (which was not possible before as those patients were on a separate site). This has increased our workload significantly as these are not the simplest patients, as you can imagine. We are still continuing our ongoing negotiations with the administration to increase our FTE to 2 pharmacists.

In regards to the team, Marie Courchesne is no longer with us as she has decided to stay with the Neurological Institute (which will only move a few years down the road). Katherine Mousseau has temporarily left us for her 2nd maternity leave (2nd boy), but she has assured us that she will be back! Nancy has (...finally ;)) decided to reduce her involvement at the Faculty of Pharmacy (Université de Montréal) (down to 15%) and so she will be more often with us in clinic. Finally, Benoît and Alison are still around, not much has changed.

The Québec Antiretroviral Therapeutic Drug Monitoring (TDM) Program has recovered after the big move and we can finally look forward and start developing again. The laboratory biochemistry is actively developing the new analytical methods for dolutegravir, elvitegravir and rilpivirine. We hope that these will be available in a few months. We will notify everyone once these tests can be ordered. We are also preparing a request to our health ministry to expand our program to include the TDM of antituberculosis medications. Benoît is taking the lead on this project.

Please note that since the move there are new requisition forms that must be used to order antiretroviral TDM. Please call us at 514-934-1934 x 32168 if you wish to order some. For more information, please don't hesitate to visit our website: www.muhc.ca/quebec tdm

Regarding research projects, there are quite a few things going on:

 The development of the screening tool is ongoing. It is now safely in the hands of 4 pharmacy residents this year who are finalizing the protocol and are submitting to the Research Ethics Board in December. We will likely have results of this study in a year. You will be solicited in January to participate in the development of the tool through a survey (Delphi Method) so I hope that you will all find time in your tight schedules to participate and help us out!

2) The study evaluating the potential clinical impact of the federal interim health program changes in medical coverage is ongoing as well. Who knows what changes will occur now that the Liberals are starting a new era...

News from Ontario

- From Toronto General Hospital, Toronto (Alice Tseng)

Michelle Foisy, Pierre Giguère and I are (still!) working on the HIV/HCV app based on our website. The end is finally in site and we hope to be able to recruit some CHAP members to beta-test a version of the app near the end of November.

- From Windsor (Linda Robinson)

The Windsor clinic is going through some changes. Most of our staff is coming into retirement status and one of our original nurses just retired this month. Unfortunately, this unleashed news from our current acute care hospital that we are affiliated with, stating that those nurse hours would only be available for coverage until the spring, end of fiscal year. Windsor is proposing that our new super hospital that is supposed to be coming, will not house any outpatient clinics. Our feeling is that the Windsor HIV clinic will be looking for a new home and status sometime in the next year or two. Needless to say I am involved in the fight to keep the "team approach" alive, highlighting the necessity of the pharmacist/pharmacy.

On another note, Melanie and I are still sharing the position approximately 75% me and 25% Melanie. Our residents from last year will both be submitting their research projects as abstracts to CAHR this year and we are submitting to journals for publications currently. One looks at the utility of patient self-assessment for depression and adherence and the other is a case series of 7 patients treated successfully with StribildTM/darunavir.

As for some other projects I am or have been involved in, I can inform all of you that the updated version of the Medrec form that I spoke about at CHAP AGM last year will be available for download soon on the CHAP website. There was supposed to be a workshop series and printed available colour copies, but unfortunately our friends at Janssen have pulled out of that commitment to the completion of the project. I am excited to be working on a desktop reference for quick ARV DDI information with Alice Tseng, Rachel Therrien, and Mike Stuber. Some of my latest speaking engagements are either on DDI or resistance, as there seems to be an interest in this area resurfacing. Perhaps it is new staff. I think we will see a lot of changeover in staffing in the next five years, as some of the original HIV gurus (including myself) approach retirement. This, I am hoping, will offer many opportunities to educate and train the newcomers to carry on our legacy.

News from Manitoba

- From the Manitoba HIV Program (Shanna Chan)

Greetings from Manitoba! We are looking forward to people coming for the CAHR conference in May 2016 and the CHAP AGM May 11, 2016!



In Manitoba, we continue to see an epidemic of newly diagnosed patients with a transmitted drug resistant strain of HIV (M41L, L210W and T215S), clade B, with 11 patients in 2014 alone. We are fortunate to be working with Dr. Richard Harrigan at the BC Centre for Excellence in HIV to phenotype six patient samples. By learning more about this strain, we hope to use this information to help guide current antiretroviral therapy for these patients (simplification) as well as use the collective information to aid the selection of regimens for new cases with the same mutation pattern. It will also help us determine if tenofovir / emtricitabine will offer protection if people chose to use it for PrEP.

This past summer/fall, I participated in a pharmacy residency project within my health region (Winnipeg Regional Health Authority) that is evaluating clinical pharmacy services within collaborative ambulatory care clinics. For 3 months, select ambulatory care pharmacists were asked to track their activities. With the information the study will look to quantify and assess how the pharmacists' practice align with evidence based key performance indicators, as well as assess differences in practice trends between pharmacists working 3 or more years compared to less than 3 years. Another component of the study was a survey to the pharmacists' healthcare team members to determine their perspective on ambulatory clinical pharmacy services. Analysis is underway and it is anticipated the results of the study will be submitted for presentation at an upcoming Canadian pharmacy conference in early 2016.

News from Saskatchewan

- From Regina (Mike Stuber)

Nothing too exciting going on here in Regina, but work continues on the particular challenges we have with delivery of pharmacy services to rural and remote/northern communities in Saskatchewan with our limited pharmacists throughout the province (myself and Shannon Stone in Saskatoon as only dedicated HIV coverage). I will be attending some rural clinics as our physicians have begun limited ID service to some reserve communities around Regina and in the north.

As far as CHAP initiatives go I am involved with the development of the DDI tool with Linda Robsinson, Alice Tseng and Rachel Therrien that should be ready by the new year. I am continuing to teach the HIV section of therapeutics to fourth year pharmacy students at the University of Saskatchewan. As well I gave a WebEx seminar in September to pharmacists in Saskatchewan on HIV. I am exploring the development of a more formal mentorship or shadowing experience as there has been interest from a number of community pharmacists who would like to develop their knowledge in HIV practice.

News from Alberta
