CHAP AGM SUMMARY

The annual CHAP general meeting (AGM) was held on April 5th 2017 at Hotel Bonaventure Montréal CAHR as а conference ancillary event. This year's CHAP AGM was again a success and a great day for discussion on HIV and viral hepatitis pharmaceutical care and knowledge sharing. Sixteen working group members and four general members participated in the daylong AGM meeting. The meeting was presided by the CHAP chair, Nancy Sheehan (McGill University Health Centre, Montréal).

Dr. Thibault Mesplède (PhD, Lady Davis Institute, Jewish General Hospital) gave a plenary during the breakfast symposium on integrase inhibitor resistance. Dr. Mesplède presented interested data and discussion on HIV drug resistance to integrase inhibitors (raltegravir/elvitegravir/dolutegravir/cabot egravir, bictegravir). This was followed by a discussion of antiretrovirals in the pipeline by Dr. Kevin Robillard (PhD, Scientific Medical Liaison, Viiv Healthcare). During the lunch symposium, Dr. Steven Shafran (MD, FRCPC, FACP, Professor, Division of Infectious Diseases, Department of medicine, and Director, Hepatitis Support Program, University of Alberta) described the challenges associated to the treatment of HCV-infected patients after direct-acting antivirals failure.

The business portion of the meeting was comprised of the treasurer's report, discussion around changes to the terms of references, CHAP position statement on Universal Access to ARV, CHAP endorsement of nPEP/PREP guidelines and election of the 2017/2018 secretary (Karen Tulloch, Oak Tree Clinic, Vancouver). The 2016/2017 secretary becomes the CHAP chair for 2017/2018 (Dominic Martel, Centre hospitalier de l'Université de Montréal, Montréal).

Of note, one of the highlights of the AGM was a change in our network name to the:
Canadian HIV and Viral Hepatitis
Pharmacists Network (CHAP) / Réseau canadien des pharmaciens en VIH et hépatites virales (CHAP).

Updates on the various CHAP projects were given by the projects leader including projects on CHAP observership program, HIV guide pocket card, dolutegravir – metformin drug interaction project, screening tool project for HIV pharmacists, pharmacy POCT (APPROACH study), ARV teaching tool, HCV drug coverage table. Presentations were

also given on various topics such as treatment of multiresistant HIV, complicated to treat HCV, generic antivirals, pediatric HIV case presentation and HIV prophylaxis duration in HIV – exposed neonates, cabergoline for lactation suppression, PREP and HIV resistance, food requirement for cobicistat/elvitragravir absorption, transmission of HIV resistant viruses and rapid HIV testing as part of an emergency Prevention of Perinatal HIV Transmission Program.

THE CANADIAN TREATMENT ACTION COUNCIL TREATMENT MAP

Here is a brief update from Rounak Khan about this wonderful tool developed by CTAC. CTAC would also like to carry out a webinar with CHAP members in the future, so more to come about this tool in the future!

The Canadian Treatment Action Council (CTAC) aims to secure and ensure access to treatment, care and support for people in Canada living with HIV/AIDS and HIV/hepatitis C co-infection. Developed by CTAC, first of its kind in Canada, the *Treatment Map (TxMAP)* is a comprehensive online tool that is now available on the CTAC website and is an indispensable tool in increasing access to information on the availability of publicly-funded HIV and hepatitis C treatments throughout Canada.

TxMAP is available at http://www.ctac.ca/treatment-access-map. This tool allows community members, service providers, and policy researchers to access information about HIV and hepatitis C treatments available through provincial, territorial, and federal public drug plans in Canada.

Access to treatment is critical for the best possible health outcomes of people living with HIV and /or hepatitis C in Canada. In total, there are 18 different public plans in Canada, with roughly 40 percent of the population reliant on obtaining access to essential medicines through publicly funded drug programs. Until recently, a map of Canada demonstrating available HIV and hepatitis C treatments per province/territory and cross-jurisdictional list of relocation-related legislation and processes linked to treatment access did not exist.

The TxMAP will allow community members and service providers to interactively access

information on:

- Publicly funded provincial and territorial HIV and hepatitis C treatment information
- Treatments covered under the five federal public drug plans
- Treatments currently under development
- Cross-jurisdictional list of relocation-related legislation and processes linked to treatment access
- Links to individual and community resources to ease transition when moving between jurisdictions

The *Treatment Map* will be used to change the ways people are able to access information on drug availability nationwide and that it will strengthen avenues for access to treatment, care and support for people affected by HIV and hepatitis C.

Our clinic has been undergoing many changes in the last 6 months. We are now fully accredited with the Ontario College of Pharmacists and have passed our inspection! I have also had the joy of

training and working with Sheri Livingston, my latest HIV pharmacy protégé. She is fantastic and has taken to HIV pharmacy like a pro. The patients love her and she is doing great things with the pharmacy and the entire HIV Care Team. Are cases keep increasing, on a not so great note, and are often young MSM. We have also had 3 very late presenters with full blown AIDS in the last 3 months. This is a lot for Windsor, but may be a good sign that more people are opting for testing. As for PrEP we still struggle with coverage in Ontario and the prescribing and dispensing has the potential for poor follow up and monitoring. As I presented at the CHAP meeting, this can lead to people converting on PrEP and TFV/cytosine developing analogue resistance, a case that we had involving outside walk in clinic docs and outside pharmacies. On another note, the OHTN is partnering with us and pharma in order to bring the 9th annual ONT HIV PSG Education Day to fruition. It will be held in Toronto on Friday Sept 15th, so save the date, my fellow Ontario CHAP members.

NEWS FROM MANITOBA

- From the Manitoba HIV Program (Shanna Chan)

Greetings from Manitoba and I hoping everyone has had a wonderful winter, spring and summer. With the warmer weather, we have had an increase in number of asylum seekers cross the

Dakota/Manitoba border North including a handful of who are HIV positive and are now receiving care through our HIV program. With the addition of the newer HCV medications and change in criteria we have had an increase number of our co-infected patients eligible for HCV treatment so we are ramping up treatment. We will be welcoming back our HIV NP, Kelly, from her maternity leave and bidding farewell to Anna Marquez, NP, who was filling the position. However, Anna is staying within the HIV family and has taken a new position at Oak Tree Clinic in Vancouver! Our HIV program is continuing to develop partnerships in our Northern communities and along Saskatchewan border and expand HIV screening and services through the province. Our 3rd HIV clinic (the only one outside of Winnipeg) at 7th Street Health Access Centre has been up and running since the end of September with ~25 patients in the western part of MB no longer needing to travel into Winnipeg to receive their HIV care. We welcome Arleigh Andrushak, hired by the Prairie Mountain Health region as their first primary care pharmacist. She has been providing the much-needed clinical pharmacy support to primary care clinics including the HIV clinic at 7th Street Health Access Centre.

NEWS FROM SASKATCHEWAN

 From Qu'Appelle Health Region
 & Saskatchewan HIV
 Collaborative Regina (Mike Stuber)

Hello from Saskatchewan!

Things remain busy here in the province with the HIV infection rate increasing to 14.5/100k (+6% over 2015) with the majority of cases in the north and rural/reserve communities. With only two active HIV pharmacists (Brent in Saskatoon and me in Regina) it's been challenging to deliver pharmacy care to the communities that need it most.

I have been travelling to a few of the harder hit areas in the eastern part of the province for pop-up HIV/HCV clinics and working to make connections with community pharmacists in the far north to support our patients in those regions. We are promoting use of PrEP in some regions (800% HIV rate increase) through development of tools aimed at primary care practitioners. We have also been working hard to support primary care physicians/NPs in taking on a bigger role in HIV/HCV care to build capacity in Sask to free up our extremely limited ID physician resources. This includes education events and materials for community pharmacists to help provide comprehensive care to our marginalized patients.

We continue to push for universal coverage of ARVs through the provincial drug plan but have so far had little success.

With Saskatchewan's health regions amalgamating into one jurisdiction later this year we will face a few challenges but hopefully some opportunities towards collaboration with other care providers across the province.

Our pharmacists have all been working hard, especially with several of our staff off work on either MAT or PAT leaves. We are hoping to be back to our usual staffing levels this fall. In the meantime, we enjoy getting the occasional photo and visit from the exhausted parents.

Generic medications have started being added to the BC formulary (like the rest of the country ©) and we're hoping to realize some cost savings with this move. In keeping with this move, newer

medications such as tenofovir AF are limited to patients who demonstrate a clinical need for not using tenofovir DF.

Upcoming changes to our post-exposure prophylaxis (PEP) program include updated guidelines and a switch from Kaletra to raltegravir with continuation of tenofovir DF and lamviudine in the starter kits. With approximately 300 PEP sites in the province the replacement of starter kits should prove to be a fun summer project.

Spring is also time for the popular spring session course SOWK 452 - HIV Prevention and Care. This UBC course is offered to students in pharmacy, medicine, nursing, social work, dietetics and dentistry and run mainly out of St. Paul's Hospital. The goal of the course is to prepare students interested working in the HIV/AIDS field members of an interprofessional team. The course is a highlight of the year for me, the other faculty members and our dedicated team of peer navigators. Many past students have described the course as "life-changing" and the best course that they have ever taken.

Greetings from the Oak Tree Clinic! It was great to see everyone at the CHAP/CAHR meeting in Montreal in April and we look forward to welcoming everyone next year in 2018 on our home turf!

Taking a look back at what occurred over what turned out to be a long (long) winter... we were happy to have finalized updates to our Prevention of Perinatal HIV Transmission guideline, physician order sets, and provincial prophylactic kits (http://www.bcwomens.ca/health-professionals/professional-

resources/hiv-aids-resources/hiv-aids-clinical-guidelines).

Highlights of the updates include recommending 4 weeks zidovudine monotherapy for infants born in low transmission risk settings (i.e., maternal HIV viral load < 40 copies/mL) while infants born in higher transmission risk settings receive combination (3-drug) antiretrovirals at prophylactic doses. We are still struggling to standardize recommendations made for managing infants born in very high transmission risk settings however, where we have

infants' been changing these antiretroviral regimens to intensified treatment doses on a case-by-case basis. Challenges in this regard include questions of which drugs to use (particularly in the setting of maternal resistance), what doses to recommend, and how to make timely interventions. Additional highlights to our most recent updates include inclusion of "Guide to Interpret Maternal HIV Test results" as we found that there is often confusion among clinicians regarding interpretation of lab results obtained at delivery, as well as the use of cabergoline for lactation suppression in women living with HIV. We currently have an ongoing clinical trial with CHUSJ in Montreal evaluating the safety, efficacy and acceptability of cabergoline and hope to have results available by the end of the vear.
